Hangry Animals Movie Funding

We plan on using a portion of the project's funds for development of the Hangry Animals Movie. In this way, utility coin holders may have a lasting impact on the development of the Hangry Animals Movie ("The HAM").

While NFT and utility coin holders will not have ownership in the Hangry Animals Movie, we are working with our Hangry Legal Counsel to develop strategies that could benefit the community from movie related revenues, such as buying utility coins and burning the supply of the utility coin. In this way, the community is benefiting from the two-fold impact of added liquidity and a deflating coin supply.

OpenSea is the largest NFT marketplace with billions of dollars in liquidity having already flowed through OpenSea.





Dynamic Traits Anyone?

The Hangry Animals collection in partnership with [OneMint.io](https://onemint.io) team, will allow holders to exchange, trade and purchase new traits as the gaming and utility evolves. This is very exciting for us as it means the NFT is not static and can be tweaked to the holders preferences with new traits being dropped on the market place regularly based on releases of new features and games. (Traits will affect ranking and status in games for player skills)



Deflationary Supply

With the advent of future drops within the Hangry ecosystem, our initial supply will become deflationary. The option to mint and burn to morph into the next iteration of a Hangry Animal provides a mechanism to maintain supply value. The future drops will have equal utility and dynamic traits, as well as form the basis for a story continuation within the ecosystem such as metamorphed species, hybrid genesis Hangrys, humanoid reversal Hangrys and new alien species too. Much Hangryness awaits.



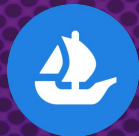


NFT Floor Tax

Much has been explored on how to ensure a stable pricing mechanism for trades. We are contemplating a floor price tax where if an NFT sale is below the the floor price or initial mint price, a heavy taxation will result on the sale. The tax fees will then be divided into a charity fund for animal welfare, liquidity for trading, and marketing support for the Hangry Animals project. The floor tax is designed to reward those that maintain a stable price action while giving back to good causes in the event someone devalues the asset below a defined price.
